3	<p><u>President's Report - Report attached</u> The President delivered his address.</p>	
4	<p><u>President's Award 2022 - Mr. Basil Jonsson</u> Vusi Tshabangu introduced the SARF President's award. "Ladies and Gentlemen, when evaluating the candidates for the President's Award we look for outstanding individuals. People who have 'made a difference'; who have enhanced the image and standing of the engineers, construction companies and suppliers who work together to make our transport world a better and safer a place".</p> <p>We all know that it takes a special individual to merit the President's Award. We called on our peers to search and identify someone in the industry who has demonstrated an extra supply of dedication, honesty, and hard work --- and who made a major contribution in the South African road industry.</p> <p>This year was no different. We are honouring an individual who has worked tirelessly to build the influence and recognition of the South African Road Federation. We acknowledge how, under his management, this organisation has grown in size and stature. Due to his presence and influence, SARF has assumed its position as the voice and supporting body for the roads industry in society. Our organisation is recognised by the government Roads Departments, academia, and the public as the source of roads knowledge.</p> <p>Ladies and Gentlemen allow me in using this occasion to recognise Basil Jonsson and the difference he has made in our industry. Basil joined SARF over 12 years ago. REPORT OF THE HONORARY TREASURER TO THE 73rd ANNUAL GENERAL MEETING OF THE SOUTH AFRICAN ROAD FEDERATION, HELD AT ETHEKWINI, 16 NOVEMBER 2023

1. INTRODUCTION

It is with pleasure that this report is submitted to the **SARF AGM 2023** for the reporting period 01 August 2022 to 31 July 2023. Included in the report is the proposed Annual Budget for 2023/2024 for consideration and approval by the AGM.

2. MANAGEMENT REPORT AND FINANCIAL STATEMENTS


The monthly Financial Management Reports were reviewed by the Treasurer for variances. The Treasurer has given feedback and made recommendations to the Executive, Council, and Head Office staff for the necessary actions where applicable.

A financial audit was undertaken by appointed auditors, Dalia Consulting, for the reporting period. Dalia has provided the report titled "Annual Financial Statements" for the year ending 31st July 2023. Dalia expressed the opinion that the Annual Financial Statements present fairly, and in all material respects, the financial position of the South African Road Federation, Not for Profit Company as of 31 July 2023, as a going concern.

3. OVERVIEW

With reference to the attached Annual Financial Statement, particularly page 7, the following overview is presented:


A. Revenue: Courses, Subscriptions, and other income



The Course Revenue generated was R 5 637 066, which is 90% of the Annual Budget of R 6 250 000.

- i. Subscriptions collected were R 1 137 705 which is 95% of the budgeted amount of R 1 200 000
- ii. Interest received was R 558 392, achieving 193% of the Budgeted amount of R 290 000.
- iii. Other Income received, including the Regional Income and the Royal Academy Project, was R 544 490.
- iv. SARF Regional Conference generated R 958 241 in profit, against a budgeted amount of R 760 000.
- v. The Total Revenue received was R 8 835 894, which is 102% of the Annual Budget of R 8 700 000.

B. Core Business Operations (Courses, Marketing, and Other Costs)



i) Core Business Operations /Cost of Sales (Including Course Costs)

The total Cost of Sales amounts to R 1 972 244, including course costs. The total cost of sales was lower than the Annual Budget of R 2 420 000, at 81% of the budgeted amount of R 2 420 000.

ii) Total Expenditure (Core Business Operations Plus Operating Expenses)

The Total Expenditure was R 7 772 770 which is 91% of the Annual Total Expenditure Budget of R 8 551 490.

iii) **Administration Costs (Personnel, Audits, Consultants, Administration, and Rentals)**

- a) The Total Administration costs are **R 5 800 526** at **95%** of the **R 6 131 490** Annual Budget amount.
- b) Salaries and Wages costs at **R 3 658 849**, **95%** of the Annual Budget of **R 3 850 000**.
- c) Regional Coordinators' costs at **R 535 123**, which is **100%** of the **R 535 500** Annual Budget.

C. Total Surplus (Revenue less Direct and Admin Expenses)

- i) The Total Surplus for the 2022/2023 financial year is an amount of **R 1 063 124**.

4. CONCLUSIONS AND RECOMMENDATIONS.

A. Conclusions:

SARF reports a total Surplus of **R 1 063 124**.

B. Recommendations:

A special mention to the team at the HO, who worked tirelessly during this financial year 2022/2023, they worked around the clock, promoting more enrolments, and when it looked like there were fewer numbers enrolled, more effort was put in. We stand proud of the collective effort in canvassing and presenting more skills programmes.

We are looking forward to more hard work, dedication, and teamwork from the HO Staff.

Basil, Jabu, Dianne, and the head office team are thanked for the diligence applied to managing the financials and containment of expenses.

5. PROPOSED ANNUAL BUDGET FOR 2022/23

The proposed **2023/2024** Annual Budget has been prepared using the revenue and expenditure of **2022/2023** as the base and in consultation with the EXCO and the Financial Committee, the **2023/2024** budget also, where possible, has reference links to the adopted Business Plan. The proposed Annual Budget for **2023/24** was presented at the recent Council meeting on 20 August 2023.



Accounting Policies

1. Presentation of Annual Financial Statements

The annual financial statements have been prepared in accordance with the International Financial Reporting Standard for Small and Medium-sized Entities, and the Companies Act 71 of 2008. The annual financial statements have been prepared on the historical cost basis, and incorporate the principal accounting policies set out below. They are presented in South African Rands.

These accounting policies are consistent with the previous period.

1.1 Significant judgements and sources of estimation uncertainty

In preparing the annual financial statements, management is required to make judgements, estimates and assumptions that affect the amounts represented in the annual financial statements and related disclosures. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results in the future could differ from these estimates which may be material to the annual financial statements.

1.2 Property, plant and equipment

Property, plant and equipment are tangible items that:

- are held for use in the production or supply of goods or services, for rental to others or for administrative purposes; and
- are expected to be used during more than one period.

Property, plant and equipment is carried at cost less accumulated depreciation and accumulated impairment losses.

Cost includes all costs incurred to bring the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Costs include costs incurred initially to acquire or construct an item of property, plant and equipment and costs incurred subsequently to add to, replace part of, or service it. If a replacement cost is recognised in the carrying amount of an item of property, plant and equipment, the carrying amount of the replaced part is derecognised.

Depreciation is provided using the straight-line method to write down the cost, less estimated residual value over the useful life of the property, plant and equipment, which is as follows:

The residual value, depreciation method and useful life of each asset are reviewed at each annual reporting period if there are indicators present that there has been a significant change from the previous estimate.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in profit or loss in the period.

1.3 Financial Instruments

Initial measurement

Financial instruments are initially measured at the transaction price. This includes transaction costs, except for financial instruments which are measured at fair value through profit or loss.

Financial instruments at amortised cost

Debt instruments, as defined in the standard, are subsequently measured at amortised cost using the effective interest method. Debt instruments which are classified as current assets or current liabilities are measured at the undiscounted amount of the cash expected to be received or paid, unless the arrangement effectively constitutes a financing transaction.

At the end of each reporting date, the carrying amounts of assets held in this category are reviewed to determine whether there is any objective evidence of impairment. If so, an impairment loss is recognised

Financial instruments at cost

Commitments to receive a loan are measured at cost less impairment.

Equity instruments that are not publicly traded and whose fair value cannot otherwise be measured reliably are measured at cost less impairment. This includes equity instruments held in unlisted investments.

Financial instruments at fair value

All other financial instruments are measured at fair value through profit and loss.

1.4 Impairment of assets

The company assesses at each reporting date whether there is any indication that an asset may be impaired.

If there is any indication that an asset may be impaired, the recoverable amount is estimated for the individual asset. If it is not possible to estimate the recoverable amount of the individual asset, the recoverable amount of the cash-generating unit to which the asset belongs is determined.

If an impairment loss subsequently reverses, the carrying amount of the asset (or group of related assets) is increased to the revised estimate of its recoverable amount, but not in excess of the amount that would have been determined had no impairment loss been recognised for the asset (or group of assets) in prior years. A reversal of impairment is recognised immediately in profit or loss.

1.5 Employee benefits

Short-term employee benefits

The cost of short-term employee benefits, (those payable within 12 months after the service is rendered, such as paid vacation leave and sick leave, bonuses, and non-monetary benefits such as medical care), are recognised in the period in which the service is rendered and are not discounted.

1.6 Government grants

Grants that do not impose specified future performance conditions are recognised in income when the grant proceeds are receivable.

Grants that impose specified future performance conditions are recognised in income only when the performance conditions are met.

Grants received before the revenue recognition criteria are satisfied are recognised as a liability.

Grants are measured at the fair value of the asset received or receivable.

1.7 Revenue

When the outcome of a transaction involving the rendering of services can be estimated reliably, revenue associated with the transaction is recognised by reference to the stage of completion of the transaction at the end of the reporting period. The outcome of a transaction can be estimated reliably when all the following conditions are satisfied:

- the amount of revenue can be measured reliably;

- it is probable that the economic benefits associated with the transaction will flow to the company;
- the stage of completion of the transaction at the end of the reporting period can be measured reliably; and
- the costs incurred for the transaction and the costs to complete the transaction can be measured reliably.

When the outcome of the transaction involving the rendering of services cannot be estimated reliably, revenue shall be recognised only to the extent of the expenses recognised that are recoverable.

Revenue is measured at the fair value of the consideration received or receivable and represents the amounts receivable for goods and services provided in the normal course of business, net of trade discounts and volume rebates, and value added tax.

Interest is recognised, in profit or loss, using the effective interest rate method.

1.8 Borrowing costs

Borrowing costs are recognised as an expense in the period in which they are incurred.

This report provides a broad overview of SARF operational activities for the year 01 August 2022 until 31 July 2023

This Report will be presented by reporting on the Strategic Clusters, Objectives and Actions as identified in the SARF Business Plan.

A Stakeholder engagement

A1 Establish a broad membership base representing road users and providers.

*Since the January 2023 SARF Exco meeting **Twenty-Four** new individual members joined SARF, **One Class B Member-TS Consulting, Two Class C Members:** Testpro Laboratory and Bowa Marang Environmental Management & Consulting*

During the same period there was 4 SARF Members resignation EGIS Operations SA, Penny Farthing Engineering Tolling, Infrastructure Services. Element Consulting (they are in liquidation).

JX has signed up the Northern Cape Dept of Roads and Public Works and Northwest Province Department of Public Works as SARF Members; they requested several of the SARF Training courses for their engineering staff. They will also form part of the SARF Central Region which will include Free state, Northern Cape, and Northwest provinces.

SARF is a member of the Western Cape Road User Charge Forum and through Prof Stephan Krygsman of Stellenbosch University and his team, a well-designed Advert will be placed in all the local Western Cape Newspapers requesting public opinion on Road Funding by clicking on a QR Code and completing a questionnaire. The SARF logo is on the Advert. The first line of the advert reads: Research being conducted by the Western Cape Government and supported by Stellenbosch University, Sabita, and the South African Road Federation would like your opinion about road funding.

B2 Promote appropriate administration of public funds to enable efficient application in road provision and preservation.

SARF Road Funding AV has given industry and the man in the street a better understanding of how public funds are used to fund both new Road construction and maintenance of roads.

B3 Create public awareness of the value of adequate and well-maintained roads.

SARF is one of the members of the Road Maintenance Forum organizing committee; two virtual workshops were held in 2022 the first one was held on 8 March and the second one on 5 October, both courses were very well attended by +/- 300 delegates A third RMF Workshop was run on 13 April 2023 to coincide with International Road Maintenance Day 332 delegates attended this session.

C Safety in road provision and use

C1 Assemble and disseminate information on the state of road safety.

BJ was asked to give a short presentation on the Botnar project for the of Anglo-America Limpopo Road Safety Programme – Tech Steering Committee on 28 October 2022.

C2 Learner education through local and international partners

- *The SARF Northern Region's committee has investigated the infrastructure improvement of the Rose Park Junior Traffic Training Centre in Gauteng, BJ, Kobus Labuschagne and Garry Savill met with Councillor Imran Moosa and the Joburg Emergency Services team at Rose*

Park in Lenasia to discuss the way forward once the upgrades are complete, children will receive Road Safety training by the relevant Traffic Department officials.

- *The SARF Council has allocated R100 000 towards the purchase of Container offices and ablutions for the SARF Western Cape JTTC.*
- *The SARF Council has approved R30 000 for prize money for the winning children's entries in the 2023 SARF KZN Regional Poetry and Essay competition that is jointly hosted by SARF and the ETA. The prize-giving function was scheduled for 2 June at the Moses Mabhida stadium. The very successful event was attended by 180 people.*

C3 Public education for road users and NMT

The SARF Road Safety Committee is planning a virtual NMT Seminar for August 2023. A subcommittee will develop a program for a morning session.

D Capacity development in the road sector

D1 Adequate skills in the roads industry through establishing training and education needs and presenting courses to meet these needs.

Present regular courses and seminars on relevant topics in the road sector

- *66 virtual courses have been planned so far this year, of which 51 have been held with a total of 1,800 delegates. This compares very favourably with 1,690 delegates for the whole of 2022.*
- *There are currently 14 delegates registered for the Urban Drainage online course.*
- *Thirteen classroom courses (Road Safety Audits, Traffic Safety Officer/Roadworks Traffic Management, Bridge & Culvert Inspectors course, Routine Road Maintenance, and the Urban Stormwater Management course) have been presented so far this year with 302 delegates. This represents an increase in the number of classroom course delegates compared with 2021 and 2022. 101 delegates attended classroom courses in 2021 and 318 in 2022.*

BJ has secured and introduced the following new SARF Technical Training courses:

- ***Riding Quality*** -Julius Komba-22 August
- ***Routine Road Maintenance*** -Marthinus Wilken 2 Classroom course has been presented and a third course is scheduled for Cape Town on 19 and 20 June
- ***Project Management Fundamentals for Road Engineers***- Zwelibanzi Moya
- ***Practical Data Science for Roadway Professionals***- Leverage Data Science &AI to improve your road and transport operations- Dr Mehran Mazari -IRF Global
- ***Public Officials /Officers Capacity Development on the Safe Systems Approach***". SARF has been appointed by Impact Catalyst to develop and present this course in Limpopo province in October and November 2023.

- **Road Safety Engineering Course** -The SARF Road Safety Committee through Basil Jonsson has requested Siegfried Grosskopf and Klaus Smidt to develop a Road Safety Engineering course.
- **HDM-4 Course** – Andrew MacKeller (SANRAL HO) supported by Prof Alex Visser on the practical applications of HDM-4 in November 2023.

iRAP Uganda offered SARF 15 free iRAP Training courses (normal price \$200) for SARF members to attend, in the end, 17 SARF engineers have been accepted and the delegates will have to allocate 20 hours to complete the online training program and complete and submit the 4 assignments before the end of May 2023

SARF together with SANRAL will be developing a Routine Road Maintenance Qualification that all RRM's will be able to attend. The qualification has been approved by the Quality Council of Trades and Occupation (QCTO) There will be a lot of work to develop the relevant modules and find experienced presenters to present these modules.

BJ secured the support of IRF Geneva who are advertising the SARF Courses to their members. All SARF Courses are advertised in US\$ on the SARF Website for the international delegates.

The South African Road Federation has upskilled 80 Female Civil engineers in the 8 local South African Metros

SARF received funding from the Royal Academy of Engineering in the United Kingdom to upskill 88 female Civil Engineers, Technologists, or Technicians at no cost to your Metro on 4 Engineering Council of South Africa accredited Continuously Professional Development (CPD) Training Course plus 2 one day and one two-day Workshops from November 2022 to May 2023.

SARF trained 88 Female Civil Engineers, Technologists, or Technicians on 4 Virtual Technical Training courses from the 8 South African metros. The 4 Technical courses have been specifically chosen to give female engineers from the 8 Metros a broad understanding of the technical skills required to better understand the relevant Civil engineering requirements of a Local Authority.

The following 7 Technical Training Courses were offered:

- 1 Introduction to Road Materials Engineering - 2 Days 2 CPD Points-Completed in Nov/Dec 2022*
- 2 Gravel Road Design, Construction, and Maintenance - 2 Days 2 CPD Points*
- 3 Design and Construction of Surface Treatments - 3 Days 3 CPD Points*
- 4 Urban Stormwater Management, Design, and Construction - 2 Days 2 CPD Points*
- 5. Community Engagement - 1 day 1 CPD Point*
- 6. Estimating, Costing, and pricing of tenders - 1 day 1 CPD point*
- 7. Project Management Fundamentals for Road Engineers - 2 days 2 CPD Points*

D2 Investigate alternative up-to-date teaching techniques.

SARF has converted +/- 54 Training courses to the Microsoft Teams platform currently 94% of SARF Courses are presented virtually.

D3 Student support for studies congruent with the aims of SARF

The SARF Bursary Committee met on 9 December 2022 to evaluate the bursary requests received for 2023. 64 Applications were received 28 Bursaries were awarded with a value is R294 000. To date, R178 200 has been paid to bursars.

KZN CHAIRPERSON'S ANNUAL REPORT TO THE SARF Regional AGM Oct 2023

1. Corporate Matters

The KZN region met on 19 January 2023 and continued on the MS Teams platform with good attendance. Two face to face meetings were scheduled during this calendar year.

Wesley Williams from Armco has been selected to represent the SARF Road Safety Committee. He has taken over the role of Marizelle Maritz who has resigned from Armco. Marizelle Maritz has however been co-opted into the committee as her new employer Mentis Africa is a member of SARF. She remains the sustainability champion. Daniel Harrilal represents the committee on Road Safety matters.

Other members have been requested to fill the relevant roles left by some committee members. We have welcomed new members from new companies and new members that have replaced seasoned individuals in our committee.

Royal Academy of Engineering in UK grant is sponsoring 15 female trainee engineers from eThekweni to attend the four training courses. The Region is trying to encourage these recipients to become actively involved in the Regional committee and the various activities.

It has been a busy year for the region with all events planned. We said goodbye Prudence – SARF Secretary who has resigned -so the administration support has been somewhat compromised. This has obviously been further affected with the departure of both Basil and Dianne at the Head Office. This together with the National AGM and Seminar being scheduled in Durban has created some challengers.

The KZN Region is hosting the regional AGM on 26th Oct 2023 at ARRB systems in Pinetown. Here will discuss the next term of SARF KZN.

2. Focus Areas for 2023

These are summarized below: -

- Webinars for understanding intricate daily works: these will help drive members to take the full course offered by SARF (1-2 hours max)
- Road safety roadshow/ contribution to schools in KZN

- Social Event – Outdoor Soccer Tournament
- Women's Month Function
- SARF Nationla AGM /Seminar to

2.1 Site Visits

- A site visit to the Colas Plant in Jacobs was undertaken on 12 May 2023 with 20 attendees. The visit covered the following aspects.
- Factory
- Bitumen storage
- Workshop/Equipment
- Research and Development Lab

The visit to Colas South Africa was informative and insightful. Attendees gained a clear understanding of the range of products and services offered by the company and were impressed by their advanced technology and equipment used in their operations. The specialized plants, laboratories, and workshops were impressive, and it was good to see the company's commitment to sustainability through their continuous development.

2.2 Webinars

The first webinar for the region was held on the 4 May 2023 with about 82 Participants. The webinar was presented by Andile Gqaji and provided an overview on Road Safety Audits. The feedback has been excellent, and indications are that this provided an appetite for attendees to attend future sessions on this topic.

The second webinar was held on the 8th June 2023 and was presented by Revash Dookhi from eThekweni Municipality titled Traffic Impact Assessments. This webinar provided a snapshot of the course that Revash presented on behalf of SARF recently.

The webinar attracted a noteworthy attendance of 152 people, and everybody took away so much of knowledge at this webinar.

Revash Dookhi brought valuable insights regarding TIAs and provided valuable technical knowledge on the subject. The information and research presented was interesting, showcasing the extensive work undertaken to produce such insightful results.

The 3rd Webinar was presented by Patrick O'Leary on the 20th July 2023 titled Truck Issues in KZN/SA. The webinar attracted 81 attendees and various causes of the high incident rates associated with heavy vehicle accidents were explored. There has been a serious shift of freight from rail to road over the years resulting in abysmal road safety record. Road maintenance and poor vehicle maintenance has been identified as the key factors for the carnage on our roads.

2.3 Schools Programme SARF/ eThekweni Municipality

On 2 June, the City's eThekweni Transport Authority Unit's Road Safety Branch in partnership with various stakeholders, including the South African Road Federation (SARF) and the Department of Education held the finale of the Road Safety Poetry and Speech Schools Competition at the Moses Mabhida Stadium. The competition was segmented into 3 categories viz: -

Category 1 Poetry 18 schools,

Category 2 Speech 24 and

Category 3 (LSEN) 4 schools

Promoting good road safety practices among their learners bore fruit for local schools when they were awarded a total of R30 000 worth of prizes by the South African Road Federation for their road safety initiatives. The submissions from the schools were of a high standard and the panel had to really apply their minds in order to choose the winners in each category.

The annual competition challenges learners to prepare a one-page essay or poem about road safety concerns around their respective schools and the interventions undertaken to address them.

The Road Safety Poetry and Speech Schools Programme aims to support the national curriculum statement on road safety education in schools. It is also aimed at promoting good road safety practices among learners and to raise public awareness.

2.4 Woman's Day Event – August 2023

This is another flagship project of the region and was celebrated on 24th August 2023 at the Oyster Box in Umhlanga, Durban with a phenomenal attendance of 120 delegates. The dress theme was Bridgeton and each lady that attended has taken this theme and glamorized it to another level. The programmed theme was "Cracking the Code on Road Safety", Vibrant speakers from road authorities, private entities and self-upliftment bodies were invited to solely crack this code and outline a message of safety on our road infrastructure. It was a beautiful day to celebrate women and enjoy the delicious High tea supplied by Oyster Box. A huge thank you to our sponsors: ARRB SYSTEMS, MAC Cosmetics, Hanslab Consultants, Nankhoo engineers, Aqua Transport, Dlamcom Construction Group, Kaytech Engineering Fabrics, Kapture, MPAMOT, Ezolile Spa and Beauty and Handpicked Baskets. At the end of this project there were a surplus of funds, SARF KZN have decided to collaborate with SAICE and WOMENG to engage with secondary school to chat about STEM subjects. Here SARF with a consulting and contracting company donated stationery hampers to help kids with their learning making the right decision with their education.

2.5 Soccer event

A Soccer tournament event was held on 15th September 2023 in Pietermaritzburg. SARF hosted various consulting and contracting companies. 12 teams played against each other to become the winners for 2023. SARF hosted approximately 150 people at this event. There was an attendance of 50 ladies from various companies within the roads and transport industry. A one-day workshop on the new vs old Road Safety Manual is also on the schedule.

SARF is a sponsor member of the Road Pavement Forum and will be contributing to the next meeting to be held virtually on 22nd November.

Safety In Road Usage

Junior Traffic Learner Centre

This project is almost complete, with a few outstanding matters requiring implementation. Full completion is expected in the first quarter of 2024.

Road safety audits

It is planned by SARF WR to offer a one-day workshop dealing with the difference between the old 2012 RSA manual and the new one, once the new manual has been gazetted. There are apparently still a lot of comments from the industry on the new manual which have to first be addressed. This will only be carried out in the new year.

City Of Cape Town Traffic

The Committee continues to receive monthly traffic statistics from the City of Cape Town's representative. A year-on-year comparison is made on enforcement statistics and traffic arrest statistics.

Safely Home Programme.

A monthly report is tabled for discussion by the Committee and the initiative has reached a milestone of 15 million viewers on social media since inception in 2011.

Road Sector Capacity / Road Provision and Delivery

Monthly tender activity is discussed based in information tabled by Safcec, Sanral, Western Cape Government and the City of Cape Town.

With only one refinery left producing bitumen in South Africa, the issues relating to importation and quality remain a concern for the industry.

Extortion by criminal elements have seriously affected delivery on projects and is now of national concern.

Education

Road Safety Education.

Our Committee is following on from the success which the KZN Region had with their Schools Poetry Competition. This initiative has commenced and will see completion in the first quarter of 2024.

Safety on Construction Site

A work procedure document has been prepared, which will serve as a guideline for this working committee to progress with actions in the coming year. This document is understood as a work-in-progress document with changes still being made.

2023 Courses

During 2023, 42 different courses were presented, seven of which were classroom courses, 34 virtual courses and one online course. Many of the courses were presented more than once and thus a total of 15 classroom, one online and 55 virtual courses were presented during 2023. A total of 2 320 delegates attended these courses (as at 8 Nov and including registrations for courses in Nov and early Dec), which is up from 1 690 delegates in 2022 and slightly down from the 2 440 delegates in 2021 (a SARF record). The main reason for the large number of delegates in 2021 was due to a series of courses on the new COTO specifications that attracted a total of 1 507 delegates (29 virtual courses) during that year. The number of delegates attending courses during 2023 is the 2nd highest after 2021. The number of classroom courses presented increased from 6 in 2021 to 11 in 2022 and to 15 in 2023. During 2023, the number of delegates attending courses was boosted by a Royal Academy of Engineering funded project, which involved six courses and 528 delegates. It is expected that the number of classroom courses will continue to increase post the 2020/21 Covid pandemic. However, there is no doubt that virtual courses will continue to predominate in the foreseeable future.

New courses that were presented during 2023 were as follows:

- Riding Quality – Julius Komba
- Project Management Fundamentals for Road Engineers – Zwelibanzi Moya

- Practical Data Science for Roadway Professionals (Leverage Data Science & AI to improve road and transport operations) – Dr Mehran Mazari, IRF Global
- Public Officials/Officers Capacity Development on the Safe Systems Approach
- Road Safety Engineering Course – Siegfried Grosskopf and Klaus Smidt


The Brake & Tyre Watch training events commenced again in 2023 (3 training events have been held so far this year), but the SARF ExCo decided that SARF would not participate as a partner/sponsor.

Table 1 shows a history of the number of courses held, venues and number of delegates since 1997. During 2023, the average number of delegates for the virtual, classroom and online courses was 33, an increase from 20 and 29 during 2022 and 2021 respectively. The total number of delegates (including current registrations for upcoming courses in Nov and early Dec) was 2 320, which, together with the number in 2021, is an excellent achievement considering the significant challenges facing the organisers and presenters since the Covid pandemic.

MoU's with other organisations

During 2020 SARF signed a Memorandum of Understanding with SAICE regarding the joint presentation of 12 SARF courses. It is believed that this will increase the exposure of the SARF courses to the roads industry, particularly the private sector, resulting in increased course attendance. The committee is continuing to monitor the attendance of these courses compared with previous years.

CPD Validation

As a Voluntary Association (VA) with ECSA (since 2011), SARF manages the validation of all their courses. This saves the organization approximately R 100 000 per annum. All courses are CPD validated.

SARF a Voluntary Association of the SACPCMP

During 2015 SARF registered as a Voluntary Association with the South African Council for Project and Construction Management Professions. The SACPCMP CPD Committee has accredited 13 SARF courses to date.

Courses planned for 2024

Planning for courses in 2024 has commenced. The first courses are expected to be presented by late January/early February.

Grants

SARF awards grants to suitable applicants for full-time and part-time post-graduate and undergraduate studies at Universities and Universities of Technology in the areas of Road Transport Engineering, Transport Management and Transport Economics. Grant applications are accepted at any time during the year. The grant committee met during January to evaluate applications for 2023. Twenty-nine grants

were awarded. The total amount paid was R178 200, a decrease from R225 587 in 2022.

ROAD SAFETY COMMITTEE

Chairman's Report for AGM: 16 November 2023

This report is written in the context of the SARF Business Plan.

1. CORPORATE MATTERS

To date, six virtual Road Safety Committee meetings have taken place, and the average attendance was 15 members per meeting.

2. STAKEHOLDER ENGAGEMENT

Traffic Law Enforcement for Safer Roads (RTIA)

The lack of traffic law enforcement on all roads is of major concern. There is an initiative of the RTMC's law enforcement branch and SANRAL to try to resolve the problem, especially on roads where Road Rehabilitation is taking place, but there hasn't been feedback on any progress yet. There have been litigations around the constitutionality of the AARTO Act with Chief Justice Raymond Zondo ruling on 12 July 2023 that the AARTO legislation is constitutionally valid and thus legal – thus dismissing the OUTA challenge. The committee now awaits feedback from its RTIA members on the further implementation of AARTO.

3. SAFETY IN ROAD PROVISION AND USE

3.1 ENCOURAGE RESEARCH AND DEVELOPMENT

- **TMH 24 & TRH 29**

A COTO meeting did take place, which dealt with a variety of TMH and TRH documents. TMH 24 and TRH 29 however remain draft guidelines.

- **Traffic Injury Study**

The main goal of the Traffic Injury study is to "measure" the cause of traffic-related problems and to implement solutions. Work was being done in terms of a dashboard display via the Limpopo Road Safety program, but receiving a consistent stream of valid verified data that could be published and updated frequently, remains problematic.

- **SANRAL Research Projects**

The process, in terms of SANRAL's collection of research areas and the ranking of topics, was explained to committee members. An official SANRAL spokesperson is yet to be identified for future liaison in terms of research projects.

- **Crash Testing of Mini Busses and SUVs**

A crash test would be performed in 2024 but would not involve a minibus.

3.2 CAPACITY BUILDING and KNOWLEDGE TRANSFER

- **Technology**

The concept for the Road Safety Engineering course was finalized and the first 5-day course took place from 31 October to 4 November 2023.

- **Engineering for a Safe System Forum (ESSF)**

SATC has indicated that there might be an additional sponsorship that will showcase TMH24 and the practical application of RAPSA, as part of a masterclass. Confirmation was awaited from the convention board in terms of dates.

- **Demonstration Projects**

A special needs school, in Talitha Kumi St, Derdepoort (close to Baviaanspoort Rd) Pretoria, had been identified as a potential demonstration project. Tshwane will forward the draft plan that includes the findings of the site investigation for further consideration. A recommendation was made to use fluorescent yellow-green road traffic signs since it was a vulnerable road user situation.

- **NMT – Safety of Pedestrians and Cyclists**

A decision was made to not include NMT as part of the Safe Systems Orientation course since it was a complex and broad topic and to rather compile a separate extensive course.

ASSEMBLE AND DISSEMINATE INFORMATION ON THE STATE OF ROAD SAFETY

The Dashboard was not updated since reliable data could not yet be obtained from RTMC.

4. COMMUNICATION AND MEDIA RELEASES

Currently, social media is the main driver in communicating with the industry and SARF's LinkedIn followers have reached 6458 followers.

5. LIAISE and COOPERATE WITH LOCAL AND INTERNATIONAL INSTITUTIONS, ORGANISATIONS AND GROUPS

5.1 Safer Road Infrastructure for South Africa Project

The Limpopo Road Safety Programme was progressing well and supported initiatives and new opportunities under the 'Safer Roads' pillar of the Decade of Action.

5.2 Universal Access and Design Forum (UADF)

The process to finalise SANS 10400 (The application of the National Building Regulations Part S: Facilities for persons with disabilities), including international documentation was almost completed and would be published for comment soon.

The establishment of the forum itself had unfortunately not progressed further, despite international developments and conferences. A separate forum was required to ensure that all stakeholders were aware of the latest requirements, and expectations from a legal perspective, as well as from a standards development perspective. A directive will be drafted, listing the priorities, challenges, and the way forward.

5.3 Impact Catalyst Funding for Road Safety in Limpopo

The first two Safe Systems Orientation courses took place in Polokwane on 10 and 11 October and 7 and 8 November 2023.

6. AID IN THE ENHANCEMENT OF KNOWLEDGE OF DECISION MAKERS

This point has a direct bearing on the Decade of Action and a proposal was made to arrange a seminar, with the assistance of the NGOs, and invite the relevant Government Departments. In the meantime,

SARF was awarded the Limpopo Road Safety Programme Safe System Orientation Course Project and will roll out two courses in Polokwane. The course will also be considered for rollout in other regions in the future.

7. REGULATIONS, SPECIFICATIONS, STATUTORY REQUIREMENTS AND STANDARDS

- **COTO Standards**

SANRAL is in the process of compiling the comments received from stakeholders and a further extension for comment was requested.

- **SABS Standards for Road Traffic Signs**

The Standards Technical Committee working group has completed the revision of the standard for Road Works Delineators and feedback is awaited from SABS Standards on whether the draft could be circulated as a revised standard.
